

**Evendale Elementary School  
Parent Involvement Policy  
2018-19**

Evendale Elementary School jointly developed this parental involvement policy in consultation with school personnel, community members, and parents and adopted it on September 13, 2018. Evendale Elementary School will:

- (1) Convene an annual meeting on September 13, 2018 to which all parents of children attending Evendale shall be invited and encouraged to attend, to inform parents of their school's participation in School Wide Title I and to explain the requirements of Title I, and the right of the parents to be involved;

### **Part 3. BUILDING CAPACITY FOR INVOLVEMENT**
